Abina stressed it would be important for Circles to have had an audit for period ending 31st March before the consultancy period was outlined some of the difficulties Circles was facing with Accountants. their It was agreed that COW would contact to check availability and in addition Circles Vincent investigate alternative Accountants. Abina to compile all the legal information affecting the merger for October.
  - 4. Jenny and Liane briefly gave an update on the work done so far around looking at both organisation's internal working thods. A completed document detailing advantages, disadvantages and recommendations would be completed by October.
  - 5. LBGS had sent application form but the closing date was at the end of the week and did not give enough time for the groups to put together an application. GLA had indicated that the groups could not apply for next year's funds for the new organisation in advance. It was agreed that Sarah should meet with Felicity to discussing funding for next year.
  - 6. The meeting discussed the importance of planning and development in the new organisation. It was agreed that the organisation's public profile should be developed at festivals and conference. Publicity material should be of a consistent standard etc.
  - It was agreed that Lianne should contact Women Make Movies to arrange a visit during her holiday in New York.
